John Jennings President & CEO, Waste Pro USA **New CNG Facilities in Daytona, Palm Coast, and Jacksonville**

At the end of last year, Waste Pro announced the opening of two Compressed Natural Gas (CNG) fueling facilities in Palm Coast and Daytona Beach, Florida and the construction start of a CNG complex in Jacksonville, Florida.

The Daytona and Palm Coast stations have the capacity to time-fill 26 CNG solid waste collection trucks, with expansion capabilities to fuel as many as 45 trucks simultaneously. With a slightly larger system, the Jacksonville location is able to time-fill 50 trucks, with the capability to expand to handle upwards of 80 trucks and is expected to be completed in early 2014.

Waste Pro's first compressed natural gas fueling facility officially opened its doors in

2012 in Ft. Pierce, FL, as the first phase of Waste Pro's \$100 million total investment towards the transition to the environmentally friendly and domestically available CNG fuel, which was announced in late 2012. Partnering with Waste Pro in the design and construction of these state of the art facilities were Mansfield Gas Equipment Services, J.R. Leonard Construction Company/CNG Services Group and Clean Energy.



Waste Pro Expands Footprint in Deep South

Waste Pro broke into the Mississippi - Louisiana market in 2010 and has not looked back since. With several well timed and strategic acquisitions, along with competitive pricing and impeccable service, Waste Pro has continued the trend of expanding its service reach throughout the Deep South Region.



In 2013, approximately 35,000 new customers were added to Waste Pro in Mississippi cities including Natchez, Petal, and Grenada, along with Noxubee and Adams County. The increase in service coverage resulted in two new divisions being established, with one in Southaven, MS and the other in Greenwood, MS and an increase of revenue totaling more than three million dollars per year.

Leading the charge in this area are two of Mississippi's favorite natives, former NFL stand-outs, Sammy Winder and Deuce McAllister. Continuing the trend of separating Waste Pro from the competition, newly designed graphics were commissioned specifically for the service vehicles in this area, bearing the images of Winder and McAllister.
