Waste Pro Poised for Long Term Growth

Wells Fargo Bank's confidence in Waste Pro has resulted in the \$579 million recapitalization of the environmental services firm. "This transaction is unusual in that it is all debt, which means a high level of confidence in the future growth of our exciting company. Our dedication to a high level of service to cities and counties is part of our distinctive difference," said John Jennings, President and CEO of Waste Pro.

Waste Pro, valued at more than one billion dollars, had 2013 revenues of \$510 million in

its eight-state Southeastern United States footprint. This transaction also completes and fulfills the terms of Waste Pro's five-year \$100 million investment by Atlanta-based Roark Capital Partners.

Private ownership is a competitive advantage and makes Waste Pro particularly unique in its ability to expand operations and sustain consistent financial growth in a strategic manner. The overall growth of Waste Pro has been systematic and strategic resulting in constantly gaining market share.

Waste Pro Opens Doors to New MRF and Completes More CNG Stations

Waste Pro opened a new state-of-the-art Material Recycling Recovery Facility (MRF) in Ocala, FL on January 7th, making it the ninth facility of its kind in Waste Pro's footprint. The new 65,000 square foot Recycling Facility, on nine acres, processes plastic, paper, glass, cardboard, metals and other recyclable materials at a rate of approximately 24,000 tons per year.

The \$6.5 million investment by Waste Pro resulted in creating 21 new jobs, many of which are in the sorting department, and is located just east of Interstate 75.

Waste Pro opened the pumps to its fifth Compressed Natural Gas (CNG) fueling station this past June in Jacksonville, FL.



This facility expands the network of stations already operating in Ft. Pierce, Daytona, Pompano, and Palm Coast, Florida.

With a slightly larger system than its counterparts, the Jacksonville location is able to time-fill 50 trucks, with the capability to expand to handle upwards of 80 trucks and currently time fuels an average of 35 to 40 trucks every evening.

Waste Pro's first compressed natural gas fueling facility officially opened its doors in 2012 in Ft. Pierce, FL, as the first phase of Waste Pro's \$100 million total investment towards the transition to the environmentally friendly and domestically available CNG fuel, which was announced in late 2012.

Under the terms of the agreement, Waste Pro will receive branding and on-site activation beginning with the 2015 Major League Soccer season.




